Community Superintendent's Report: Dr. Collins reported on the following:

District 19 Priorities for SY 2023-2024 Updates:

Priority 1: All Students Learn to Read Well: By June 2024 all students will learn to read through the implementation of Foundations curriculum with fidelity resulting in a growth of 5% from 36% to 41% on the Acadience Reading Screener. - Met: EOY Acadience+ 8.2% increase

By June 2024 students will read to learn through the utilization of the MTSS framework to strengthen the implementation of core instruction to provide high-quality instruction for each learner resulting in an increase of 5 percentage points on the NYS ELA from 39.7% to 44.7%. – Did Not Meet: EOY ELA State 2023-24 -2.8%

Priority 2: All Students are Physically and Emotionally Safe: By June 2024, the number of level 4 and 5 incidents in OORS will be reduced by 5% from 347 to 329 in middle schools through the implementation of restorative justice practices. **– Did Not Meet -2 to 345**

Priority 3: All Students Have a High-Quality Academic Experience: District 19 will ensure high quality core instruction focused on building content knowledge and problem solving in Mathematics resulting in a 5-percentage point increase in proficiency on the NYS Math Assessment from 37.5 % to 42.5%.



School Level NYS ELA Assessment Proficiency %



Edmentum:

This school year District 19 is the only school district in the city selected to work with the Edmentum program. Edmentum is an online program that offers personalized learning and data-driven tools for K-12 students in math and reading. The implementation will provide support for all District 19 schools. This includes embedded classroom coaching, continuous professional learning opportunities, parent data reports, and data analysis.

New Supports for Multilingual Learners (MLs):

- For Elementary schools LUCES LUCES is an organization committed to enhancing the educational experiences of multilingual learners (MLs). Eight of our schools have been selected to participate in this new initiative which will support MLs in ELA and math. LUCES will work with school leaders and teachers as well as create a lab site for our district to enhance success for MLs.
- > For Middle Schools TRANSLATE (Teaching Reading And New Strategic Language Approaches To Emergent bilinguals) TRANSLATE: (089, 218, 661,662) Honors the linguistic assets of adolescent multilingual English language learners (ELLs) Ensures that the necessary foundational literacy skills found in the science of reading are in place for older new arrivals to accelerate their learning through core instruction in English 8 weeks pilot program in four of our middle schools in collaboration with the Office of Multilingual Learners (OML).
