Community Superintendent's Report: Dr. Tamra Collins, Community Superintendent reported on the following:

State of the District 2023-2024:

#### Pillar #1: Strengthen Core Instruction (MTSS)

DCEP Goal: By June 2024 students will read to learn through the MTSS framework to strengthen the implementation of core instruction to provide high-quality instruction for each learner resulting in an increase of 5 percentage points on the NYS ELA from 39.7% to 44.7%

As a Result... (Data Points)

- \* Schools currently administering End of Year Assessment
- MAP ELA: Fall to Winter 47.5% of students saw at or above average growth (progress)

Pillar #1: Strengthen Core Instruction (K-2)

DCEP Goal: By June 2024 all students will learn to read through the implementation of Fundations curriculum with fidelity resulting in a growth of 5% from 36% to 41% on the Acadience Reading Screener

As a Result... (Data Points)

• Acadience Data: BOY 36.4% to MOY 39.6% (Increase of 3.2%)

Pillar #1: Strengthen Core Instruction (Math)

DCEP Goal: By June 2023, District 19 will ensure high quality core instruction in mathematics resulting in a 5% increase in proficiency on the 2023 NYS Math Assessment.

As a Result... (Data Points)

- MAP Math Data: BOY 31.6% to MOY 31.8% (Increase of 0.2%)
- SWD Benchmark data: BOY 9.8% MOY 14% (Increase of 4.2%)

Pillar#2: Creating a Sense of Belonging (Attendance)

DCEP Goal: By June 2024 the District 19 average school attendance rate will increase 1.5 percentage points from 90 to 91.5%.

As a Result... (Data Points)

• Chronic attendance has dipped by 2 percentage points, down to 39 to 37%.

DCEP Goal: By June 2024 the District 19 average school attendance rate will increase 1.5 percentage points from 90 to 91.5%.

Pillar #2: Creating a Sense of Belonging (Restorative Justice Practices)

DCEP Goal: By June 2024, the number of level 4 and 5 incidents in OORS will be reduced by 5 % from 347 to 329 in middle schools through the implementation of restorative justice practices.

#### As a Result... (Data Points)

- Currently our level 4 & 5 are at 300 vs 300 prior year
- 6 out of 13 middle schools have a Restorative Justice Partnership
- 13 out of 13 middle schools have a school based restorative justice coordinator
- 10% increase in student supports & interventions entered in OORS

Pillar #2: Creating a Sense of Belonging (Middle School Advisory)

DCEP Goal: By June 2024 100% of middle school students will experience an advisory program that strengthens their organization and study skills and prepares them to begin a pathway towards college and career readiness.

As a Result... (Data Points)

- 13 out of 13 schools have an active advisory program
- 80% of students have met with their school counselors and created post secondary goals
- 5 out of 13 schools have implemented "Crew" practices in their advisory program
- Based on School counselor survey results, 13 out or 13 schools have engaged in a college visit or have had a career day.

• Wit & Wisdom coaches at all elementary & middle schools to support planning & preparation and provide job-embedded coaching

• Job-embedded coaching and professional learning for Middle School teachers in mathematics

- ELA Benchmark: Fall 27.4% to Winter 28.5% (Increase of 1.1%)

Strengthen Core Instruction For <u>M/ELLs</u>: Next Steps:

- Support schools in hiring and training ENL teachers and Bilingual teachers to answer the need of the growing ELL population.
- Assess need of additional bilingual programs in the district

#### Special Education Compliance

Current issues in 2023-24:

- Special education teacher vacancies
- General education teacher vacancies in classrooms with an ICT program (two teachers co-teach in the same classroom: one general education teacher, one special education teacher)
- Late in the year changes to IEPs at annuals/triennials (re-evaluations)

• Transfers from out of the district of SWDs into schools that don't have current classrooms to support the IEP recommendations

Next Steps for 2024-25:

- Early start on hiring Special Education teachers to fill the vacancies
- Early budget/projection meetings to determine a change in the amount of teachers to accurately support the provision of services (so earlier hiring can occur)
- ASE on staff to support School Administration with programming and Special Education concerns
- Professional development for IEP writing, SDI (Specially Designed instruction), Progress Monitoring, Paraprofessional Supports, and more
